Gender based violence chu mipa emaw, hmeichhia emaw a nih avanga an chunga tharum thawhna te hi a ni.

Gender based violence chi hrang hrang te chu pawngsual, mipat hmeichhiatna lam hawi zawnga hleihlenna, nghaisak, taksa hliam, nupui pasal inneih luihtir, an chanvo leh hamthatna pek loh (denial) leh rilru leh ngaihtuahna hliam.

India ramah hian gender based violence hi a hluar hle a. National Crime Bureau India-in a tarlan dan

chuan thuamchhawm (dowry) vanga thihna hi darkar 78 danah a thleng reng a, mipat hmeichhiatna lama in rik rapna hi darkar tina thleng ang a ni a, pawngsual hi minute 34 danah a thleng a, kut in thlakna hi minute 12 danah a thleng a, hmeichhe pasal nei pathum zela pakhat

hian tihduhdahna an tawk anga tarlan a ni.





Gender based violence against women:

Kan ramah hian gender based violence hi a hluar hle a, hei hi a ngai mawh awm em em a ni. Kan rama hmeichhia pathum zela pakhatte hi eng kumah pawh, eng hnamah pawh, eng sakhuaah pawh, eng thiamna pawh, eng khawsak/dinhmunah pawh gender based violence hi an tawk vek a. Heng harsatnate hi an inah emaw, khawlaiah emaw an hnathawhna hmunahte pawh an tawk thin a ni.

Gender based discrimination leh violence hi engtin nge kan hmachhawn ang?

- Tharum thawhna leh hleihlenna chi hrang hrang (physical, sexual leh emotional) hi pawmzam chi a ni lo.
- Mipa leh hmeichhia inthliarna avanga rilru natna thlentu hi tharum thawhna chi khat a ni.

GBV chungchanga India danpui (Constitution)-in provision a pek hrang hrang te:

Article 14

This article authorizes the State to accept every person equally. "The State shall not deny to any person equality before the law or the equal protection of the laws within the territory of India."

Article 15(1)

Prohibition of discrimination on grounds of religion, race, caste, sex or place of birth. Here the State shall not discriminate against any citizen on grounds only of religion, race, caste, sex, place of birth or any of them.

Article 15(3)

This article of the Constitution states: "Nothing in this article shall prevent the State from making any special provision for women and children. "Based on this provision, the central legislatures have enacted the child Sexual Harassment Act, the Domestic Violence Act, Workplace Harassment





Law, and the Hindu Succession Act and also made amendments to criminal law recently (Nirbhaya case).

Article 16(1)

There shall be equality of opportunity for all citizens in matters of employment under the State. (2) No citizen shall, on grounds only of religion, race, caste, sex, descent, place of birth or any of them, be ineligible for any office under the State.

Article 39(d)

States that the health and strength of workers irrespective of whether men, women or children shall not be abused or manipulated. Further, economic necessity/condition shall not be the reason for entering such avocation that is unsuitable for specific age or strength.

Article 39(A)

According to Article 39A of the Indian Constitution the State shall secure that the operation of the legal system promotes justice, on a basis of equal opportunity, and shall, in particular, provide free legal aid.

- 4) Ujjawala Scheme pakhat Comprehensive Scheme for Prevention of Trafficking for Rescue & Rehabilitation and Reintegration of Victims of Trafficking for Commercial, Sexual Exploitation kalpui a ni a. He scheme hian mihring hmanga sumdawnna tuartute chhan chhuah, chhawmdawl





leh nunphung pangngai kawng an zawh leh theihna turin hmeichhiate nasa takin a pui a ni.
